

Zhejiang Yingfeng Technology Co., Ltd.

Zhejiang Yingfeng Technology Co., Ltd. was established in 2008 with a total investment of over 2 billion yuan. The company covers an area of nearly 250 acres and has more than 3,000 employees, including over 700 mid-to-high-end talents (including senior skilled personnel). The company specializes in textile printing and dyeing processing, dedicated to providing customers with professional, integrated, and personalized printing and dyeing services. Its main products include two series of knitted fabric printing and dyeing and woven fabric printing and dyeing, involving high-end products such as brocade cotton, rayon, tencel, and warp-knitted nylon. The printed and dyed fabrics are widely used in high-end leisure clothing, sportswear, business formal wear, and other clothing fields. On January 29, 2021, the company was officially listed on the main board of the Shanghai Stock Exchange (stock name: Yingfeng Stock, stock code: 605055), becoming the first listed company in the A-share market to focus on printing and dyeing services as its main business in nearly 20 years.

The company is a national high-tech enterprise, a national-level green factory, a national comprehensive demonstration zone pilot enterprise for the deep integration of industrialization and informatization in Zhejiang Province, and a green enterprise in Zhejiang Province. Since its establishment, the company has always been committed to technological innovation and environmental protection, continuously improving its management level and service quality, and dedicated to building an energy-saving, environmentally friendly, and intelligent textile printing and dyeing enterprise. The key technology development and system integration project for the green production of the entire textile printing and dyeing process, which is led by the company, has been included in the national Ministry of Industry and Information Technology's green

manufacturing system integration project and has received special funding support for industrial transformation and upgrading from the government.

After years of development, the company has effectively met the increasingly upgrading consumer demand in the market with its strong technology research and development capabilities, strict quality management, and advanced production and environmental protection equipment. Its sales scale has rapidly increased, and the brand effect of Yingfeng printing and dyeing has gradually emerged, with a high level of market awareness and brand influence. From 2019 to 2022, the company was continuously listed in the top 30 Chinese printing and dyeing enterprises by the China Printing and Dyeing Industry Association for four consecutive years, with its overall technology level and product development capabilities leading the industry. As of the third quarter of 2021, the company's operating income was 825 million yuan, its total profit and tax was 69.26 million yuan, and its total assets exceeded 2 billion yuan.

In addition, the company has made efforts to introduce the most advanced printing and dyeing equipment in the industry, and has made every effort to build the first "smart factory" in Shaoxing's printing and dyeing industry. Through the construction of the "Internet technology + intelligent management" smart factory, the company has strengthened the management of the printing and dyeing process, energy consumption, and cost control, achieving the upgrading and transformation of traditional textile enterprises towards intelligent production and management. The construction of the "smart factory" will continue to promote the better and faster development of the enterprise, and ultimately lay the foundation for the company to become a high-end demonstration enterprise for post-processing.
