Article 1: Fashion Industry Charter for Climate Action – Progress Report – June 2021



The Fashion Industry Charter for Climate Action (FICCA) has published the first "Progress Report". It provides an in-depth overview of all the work done, action taken, and progress made since 2018. It serves as a guide how to engage in a greener (CO2-free) production of textiles.

Article 2: Climate Action Online Training for Suppliers by GIZ



GIZ is offering "Climate Action Online Trainings" to tier-1 and tier-2 suppliers. These trainings provide foundational knowledge about concrete solutions how to cut Green-House-Gas emissions in operations helping to achieve 30% emission reductions by 2030 and net zero emissions by 2050.

Article 3: Shipments of knitting machines in 2021: gloomy vs. sunny



The latest International Textile Machinery Shipment Statistics (ITMSS) shows that shipments of electronic flat knitting machines decreased by -52% in 2020 compared to 2019, while 2020 was a record year for large circular knitting machine since 2014.

Article 4: Shipments of shuttle-less looms decreased by -14% in 2020



The total number of shuttle-less looms shipped worldwide in 2020 was 114'000, down from 133'000 in 2019. Shipments of "Waterjet" looms represented 54% of global deliveries, down from 58% the year before. Shuttle-less looms in the categories "Air-jet" and "Rapier & Projectile" represented 26% and 20% in 2020.

ITMF signs Joint Industry Statement on the REACH restriction proposal on skin sensitizers

Last month, ITMF has co-signed the Joint Industry Statement on the REACH restriction proposal on skin sensitisers. Other signatories of this statement are 17 other associations and companies like ETAD (Ecological and Toxicological Association of Dyes and Organic Pigments Manufacturers), TEGEWA (Association of Manufacturers of Process and Performance Chemicals), CEC (European Footwear Confederation), FESI (Federation of the European Sporting Goods Industry), IAF (International Apparel Federation), Archroma, DyStar, Huntsman, etc.

The REACH restriction proposal aims to restrict all current and future skin sensitisers in the <u>Classification</u>, <u>Labelling and Packaging (CLP) Regulation</u>, even though this would include substances for which there is no evidence that they pose a threat to the consumer safety. It is important to note that the signatories support the overall objective of the REACH restriction proposal to reduce the risk of exposure of the general population to skin sensitising chemicals in clothing, footwear, and other articles which come into contact with the skin to an extent similar to clothing. Nevertheless, the signatories call on the European Commission and Member States to consider the following recommendations:

- 1) No automatic link with CLP.
- 2) Initial scope based on a slightly revised "Master list", not all skin sensitisers in CLP.
- 3) Allow a transition period of at least 36 months from the date a final restriction decision is adopted.


2nd edition of Sustainability Talks Istanbul
