identifies industrial gaps in African countries to unlock value and create new industries. The objective is to industrialize key sectors by creating local transformation, maximizing production, efficiency, and cost, which in turn generates local value addition.

Arise IIP (Textile Division) seeks to boost exports, enable local transformation of raw materials and promote trade by tailor-made special economic zones in <u>Gabon</u>, <u>Benin</u> and <u>Togo</u>. In Benin and Togo Arise IIP will focus at creating value chains for the textile industry – from raw material sourcing (cotton) to resource transformation through manufacturing, to exporting final products.

Oswal, Vardhman Textiles has developed into an integrated textile company and has become one of the largest spinners in the world with approx. 1.4 million spindle-equivalents.

ITMF Awards 22: Deadline for applications on April 30th

In 2022 the ITMF will for the first time recognize achievements in the global textile industry by granting awards. The so-called <u>ITMF Awards 2022</u> will be awarded in the two following categories:

Sustainability & Innovation

The objective is to recognize sustainable and innovative <u>achievements</u> in the textile industry with a focus on innovation, design, development, and production under the strictest standards of sustainability and respect for the environment. The jury will grant this award to a company/organisation or person which/who significantly improved textile manufacturing in the combined areas of innovation and sustainability.

International Cooperation

The objective is to recognize <u>progress</u> in the area of international collaboration in the textile industry according to the values of the 17 Sustainable Development Goals (SDGs) of the 2030 Agenda for Sustainable Development. The jury will grant this award to a company/organisation or person which/who significantly improved textile manufacturing through the means of international collaboration.

The ITMF is delighted that nine personalities from the industry and academia from around the world have accepted the invitation to join the jury of the ITMF Awards 2022. The winners of the ITMF Awards 2022 will be invited to attend the ITMF Annual Conference 2022 in Davos, Switzerland where they have the opportunity to present

their achievements.
